

TERMS AND CONDITIONS (APPENDIX)

This "TERMS AND CONDITIONS (APPENDIX)" constitutes a binding contract agreed between the Organizer and the Exhibitor.

Exhibitor with RAW SPACE as Contracted Space

1. The maximum construction height of single-storey booth is 4.4m.
2. Not more than 50% of the total Contracted Space can be covered with ceiling (if any).
3. Only Exhibitor with Contracted Space size of 90 sq.m. or above can apply to build two-storey booth. The height limit of two-storey booth is 6.0m, in which the size of upper-storey must not exceed 50% of the base-storey area. The upper-storey can only be used for meeting purpose and not for any display of exhibits and/or machinery. The upper-storey is subject to an additional Contracted Fee of US\$85 per sq.m., which the Organizer will bill the Exhibitor separately.
4. Design drawings of all two-storey booths must be:
 - 1) a. Examined & approved by HAH Consulting & Exhibition Co., Ltd. (HAH) — the structural engineering firm appointed by the venue operator (SNIEC); *or*
 - b. Verified by HAH after being examined & approved by a PRC chartered structural engineer. AND
 - 2) Submitted to the official contractor for filing and onsite checking after being approved by the structure engineer.
5. Co-exhibiting Exhibitors sharing the same Contracted Space can only appoint the same (ONE) contractor as their stand-builder.
6. The Exhibitor Manual, available in July 2021, will list out detailed regulations and guideline for booth construction. The Organizer will also inform Exhibitor any update on booth construction regulations as may be announced by the Exhibition Venue, such as changes of height limitation (if any), Exhibitor and the appointed contractor are required to comply with the up-to-date regulations accordingly.

Exhibitor with SHELL-SCHEME BOOTH as Contracted Space

1. Shell-Scheme Booth can only be converted to raw exhibit space with the prior approval from the Organizer.
2. Exhibitor cannot construct or erect any structure (backdrop, banner, etc.) exceeding the height of 2.5m.
3. Exhibitor consents to the installation of power distribution board/panel and/or power lines inside/outside/near its Contracted Space as deemed necessary by the official stand-building contractor.

Exhibitor displaying MACHINERY / EQUIPMENT

1. Any built-in or additional elevated platform, staircase or passageway of machinery/equipment showcased in the Exhibition Venue are for display only. For safety reasons, Exhibitors/Visitors cannot enter the elevated areas during Exhibition opening hours, unless prior approval (with governing terms and conditions) has been obtained from the Organizer.

Notes on EARLY MOVE-OUT

1. To avoid trespassers such as hawkers from occupying Exhibitor's Contracted Space, Exhibitor must ensure the Contracted Space is properly manned by their staff/representatives at all times during the entire Exhibition period. Early Move-Out or dismantling of the Contracted Space is NOT allowed before the closing time of the Exhibition (i.e. 14:00 on November 18, 2021).
2. In case of violations, contractor's deposit will be totally forfeited (if applicable). The Organizer may consider to ban concerning Exhibitor and related parties from participating in subsequent CHINACOAT events.

Notes on INTELLECTUAL PROPERTY RIGHTS

1. Exhibitor must comply with relevant laws and regulations of the P.R. China regarding Intellectual Property Rights (IPR). Exhibitor shall bring along all relevant authorization or documentations for all exhibits as proof of IPR ownership.
2. The Organizer reserves the right to request Exhibitor to remove exhibits which are alleged of violating IPR. Any possible legal consequences as a result must be borne by the Exhibitor concerned. The Organizer and/or related law enforcement authorities reserve the right to remove any articles which are found with sufficient legal proofs that violate IPR.

The Exhibitor understands and hereby confirms the acceptance of the Terms and Conditions set forth herein, which will constitute a binding contract between the Organizer and the Exhibitor, once signed by both parties.
